Brillion Seeder	\$80.00 min – 8.00/ac after 10 acres	45 minimum
Lime Spreader	\$50.00 min – 2.00/ton after 25 tons	60 minimum
Tree Planter	\$50.00 min – 50.00/day after 1 day	25 minimum – 50 maximum

Note: Seeders, drills and planters must be used prior to December 1 and will not be rented from December 1 to March 1.

2. I understand this equipment is for my use only and I assume full liability and responsibility for damages to, or caused by, the equipment from the time it is delivered until it is picked up at my farm. I agree to pay 50% of the total repair costs if the equipment is damaged during my rental time.
3. I agree to not use the equipment on areas where damage could result to the equipment from rocks, roots, posts, or other materials. **I will not put fertilizer into equipment seed boxes or use fertilizer in the lime spreader.**
4. I agree to use the equipment immediately upon arrival, weather permitting. I understand the minimum fee will be charged for delivery/pickup even if I do not use the equipment after being delivered.
5. I understand the initial settings on the equipment made by District personnel are approximate settings suggested by the manufacturer of the equipment. I understand and agree it is the renter's responsibility, while using the equipment, to check and verify the actual seeding rate and depth, or amount of lime being spread. I understand and agree the District and/or its employees cannot be held responsible for the actual amount of lime or seed used.
6. **I agree to contact the District Office at 740-992-4282 when I have finished with the equipment and report the number of acres planted, tons spread, or days used, whichever applies.**
7. **I agree to pay a \$50 cleaning fee to remove excessive debris, dirt, or mud on the equipment or an excessive amount of seed in the boxes, hoses, tubes, seed cups, and seed boots. The fee will not be assessed for normal wear or general maintenance on the equipment.**
8. I \_\_\_\_\_ agree to indemnify and hold harmless the County of Meigs, Ohio, its agents, employees or any other person against loss or expense including attorney fees, by reason of the liability imposed by loss upon the County, for damage because of bodily injury, including death at any time resulting there from, sustained by any person or persons or on account of damage to property arising out of the transportation or use of equipment rented, leased, or borrowed from the Meigs SWCD.
9. I agree to pay \$10 per month, after 60 days, on any unpaid bill. I understand that I will not be permitted to rent additional equipment until bills outstanding after 60 days are paid in full.
10. I \_\_\_\_\_ agree to pay a \$100 surcharge for any equipment rentals out of the county in addition to the regular equipment rental fees except for those living in the Leading Creek Watershed (if applicable).
