

Thomas Fork Doser

Since the Thomas Fork doser was installed in January 2012 we have been treating the orange acid mine drainage with calcium oxide (lime). The basic lime counteracts the acidic acid mine drainage. The water seeps into intake pipes then runs over a water wheel to turn an auger to drop a dose of lime into the water. We have been studying how the inputted lime transports down Thomas Fork stream during high, medium, and low flows. There have been problems with getting the lime downstream with low flows but we are attempting to study the problem and create a solution. We are currently working with gear box and sprocket ratios to find the most efficient way of inputting lime with the given amount of flow.

We continue to monitor The Thomas Fork doser's success through a weekly pH profile where we monitor seven different sites downstream of where the lime is discharged. Research data will allow us to maximize the impact that the doser has on the Thomas Fork sub-watershed. Mussel Stocking

Once upon a time Leading Creek supported a healthy freshwater mussel population of 11 species – a typical amount of diversity for a stream of its size. But when the Meigs Mine was dewatered in 1993 all mussels downstream were destroyed. A few mussels survived upstream, but the majority had been in harm's way. It was recognized from the beginning that the recovery of mussels in Leading Creek would be a long process. Steps towards this process were made once in 2011 and again on Sept 11, 2012 when the Leading Creek Watershed Group and -Ohio State University stocked two different species of mussels into two locations of Leading Creek. One of these species includes the endangered and relocated Northern Riffle Shell. Relocating these mussels is an essential recovery tool because of the extent of their population decline and their scattered populations.

For the Leading Creek Watershed group, mussel introductions increase the biodiversity. Sustaining improved biodiversity in water bodies shows positive developments in water quality. In other words, there must be healthy water to support healthy life. Lets keep improving Leading Creek watershed's health and watch the mussels flourish!

Rain Barrel Workshop

The Leading Creek Watershed Group recently received a watershed education mini-grant to be used for hosting a rain barrel workshop in April 2013. The exact date and time are to be determined but keep checking MeigsSWCD.com and the Leading Creek Watershed Group facebook for more details.

The workshop will be free and open to the public. Attendees will have a chance to assemble a free rain barrel and take it home that night!

Some of the benefits include:

Provide a backup during drought seasons.

Great water source for gardens, lawns, animals, and car washes.

Rain water is healthier for plants and lawns than treated water.

Helps prevent contamination of surface water.

Helps prevent soil erosion.

Improves water entering local water systems.

Less water is being treated at water treatment plants.



Ink Cartridge and Small Electronics Recycling

Help prevent electronic waste by recycling these unwanted or used items to the Meigs County Libraries or the Meigs SWCD.

Boxes, like the one shown below, will be set up for collection at each location.

Items accepted include cell phones, pagers, ipods, ink cartridges, ink jets, game boys, cassette tapes, cds, floppy discs, calculators, remote controls, computer mouses, cameras, and most other small electronics. *Will accept old lap tops only if they are dropped off at the Meigs Soil and Water District office.

The Leading Creek Watershed Group will continue to monitor the Thomas Fork doser and the effect on the Thomas Fork subwatershed. For anyone interested in stream quality testing and analysis, we are always accepting volunteers. See the next page for more volunteer information.

The Leading Creek Watershed Group and Ohio Department of Natural Resources/ Division of Mineral Resources Management are teamed up to combat acid mine drainage in the Thomas Fork watershed. Water monitoring and field analysis are being conducted to try and find out next project location. Project information will be updated on the Meigs SWCD website.

In the spring of 2013 we will host a watershed day camp, a river sweep and a stream sweep. These events are always a hit and allow the community to get involved in cleaning up local watersheds.


In 2013 we will host four Adopt-A-Highway events. Come help us clean up our highways and treat yourself to free pizza at the end.
